CONFIDENTIAL " TRADE SECRET" AGREEMENT

In consideration of being employed by or carrying out work experience at '0-60 Seconds iNTELEVISION Commercial Producers', referred to as the "Company". This document consists of two (2) pages.

hereby agrees and acknowledges:

1. That during the course of my employment or work experience there may be disclosed to me certain trade secrets of the Company; said trade secrets consisting of:

- a) Technical information: methods, processes, compositions, designs, inventions, machines, computer programs and research products.
- b) Business information: customer lists; customer contacts, client information, client confidentiality, client trade secret, marketing information, pricing date; sources of supply; and marketing, production, or merchandising systems or plans.

2. I shall not during, or at any time after the termination of my employment or work experience with '0-60 Seconds iNTELEVISION Commercial Producers' use for myself or others, or disclose or divulge or reproduce to others any commercial information, the clients' trade secrets, confidential information, or any other data of the company in violation of this agreement. I shall not approach directly or indirectly the client(s) to canvas for employment or subcontract work or any jobs without the written permission from '0-60 Seconds iNTELEVISION Commercial Producers' or the producer.

3. That upon the termination of my employment or work experience from the Company:
a) I shall return to the Company all documents relating to the company, including but not necessarily limited to: drawings, blueprints, reports, manuals, correspondence, customer lists, computer programs, filming equipment, other equipment, and all other materials and all copies

thereof relating in any way to the Company's business, or in any way obtained by me during the course of my employment or work experience. I further agree that I shall not retain any copies of the foregoing.

b) The Company may notify any future or prospective employer or volunteer of the existence of this agreement.

c) This agreement shall be binding upon me and my personal representatives and successors in interests, and shall inure to the benefit of the Company, its successors and assigns.

d) The unenforceability of any provision to this agreement shall not impair or affect any other provision.

e) In the event of any breach of this agreement, the Company shall have full rights to injunctive relief, in addition to any other existing rights.
